

# Intamixx Music Company

## Terms & Conditions

1. Should the CLIENT wish to hire services other than that of the Roadshow, for example, video filming or dhol player, appropriate charges will apply which are subject to prior negotiation.
2. In the event of the CLIENT wishing to cancel a booking, any deposit that has been paid will be forfeited. If cancellation is made within 21 days of the performance date, full payment of the fee will be applied for by INTAMIXX.
3. Whilst INTAMIXX will use its best endeavours to attend the function, or provide an alternative Roadshow to give satisfactory performance; should the Roadshow be prevented from doing so, for any reason outside its control, (including lateness, sickness, equipment failure or mechanical breakdown), INTAMIXX shall not incur any liability for its non-appearance.
4. The CLIENT warrants that he or she is entitled to use the venue for the purposes of the event and performance.
5. The CLIENT will allow INTAMIXX adequate setting up time, prior to the performance, and sufficient time afterwards to dismantle and remove the equipment from the venue. If, at the request or instruction of the CLIENT, the equipment and/or recorded music is to be left at the venue, the CLIENT will be liable for any loss or damage, however caused, during such times as that equipment/recorded music is at the venue.
6. Should the equipment/recorded music be left at the venue, as stated in clause (5) above, and should circumstances arise preventing INTAMIXX from gaining access to the venue, in order to remove the equipment, at a mutually agreed time, through no fault of INTAMIXX, then the CLIENT will be liable for additional expenses to cover further appointments to effect removal. Furthermore, if INTAMIXX is prevented from carrying out other engagements due to being unable to collect the equipment, the CLIENT will be liable to any expenses, or loss of earnings thus incurred.
7. The CLIENT will provide adequate supervision of all guests and/or customers and/or staff at the venue, and will be liable for any loss or damage to the equipment/recorded music, caused by guests, customers or staff.
8. INTAMIXX reserve the right to stop the performance of any venue due to fighting, abuse or miss conduct by the guests or the CLIENT.
9. The tips received by the D.JAY at the venue are non-deductible from the final amount due unless otherwise requested by the CLIENT prior to the function.
10. INTAMIXX personnel shall in no way be liable for any breach of laws, bye-laws or conditions under which any premises or property are leased, hired or entrusted to the CLIENT.
11. The CLIENT shall provide two 240 volts mains power points efficiently earthed and accessible to INTAMIXX.
12. INTAMIXX expects payment in full on the day of the function.
